B. Community of Interest the Chapter Will Serve

The Internet Society Mongolia Chapter will serve the entire country of Mongolia, with a special focus on educational institutions, underserved communities, and organizations promoting digital literacy. The Chapter will actively engage with schools, universities, government agencies, non-profits, and private sector stakeholders to advance internet accessibility and digital inclusion in Mongolia.

C. Purpose and Scope of the Chapter

We are in significant need of high-quality internet in educational institutions.

Our Chapter will address these issues by:

Promoting digital literacy and internet governance awareness across educational institutions.

Supporting equal access to the internet and digital resources, particularly in rural areas.

Encouraging safe and responsible online engagement.

Bridging the digital divide through community-based projects and policy advocacy.

Despite Mongolia's high internet penetration rate of 83.9%, approximately 16.1% of the population remains offline, primarily in rural areas. Many students must travel long distances to access the internet, while low-income households depend on costly and often inadequate mobile connections. The COVID-19 pandemic underscored these challenges, highlighting barriers to remote learning due to high data costs (1GB at approximately 9 USD, over 2% of many families' monthly income). Addressing these disparities is crucial for promoting educational and economic opportunities.

Establishing an Internet Society Chapter in Mongolia provides the necessary structure and support to implement these initiatives effectively.

This strategy ensures that ISOC Mongolia will not only grow in size but also build a vibrant, mission-driven membership base that actively contributes to the Chapter's success and sustainability.

J. Legal and Regulatory Requirements

After consultation with local authorities and with the advice of our legal help, we have already created a non-profit organization to operate the activities of the chapter nationwide. This entity ensures compliance with Mongolia's legal and regulatory framework for non-profit organizations and professional associations. We have also opened a bank account for the organization to manage funds transparently and support our activities.
